TERMS AND CONDITIONS

1. RAFFLE PERIOD

- 1.1. The raffle will run from May 1 through June 8, 2018 inclusively.
- 1.2. The raffle will include six (6) prize draws described in section 4.
- 1.3. The draw will be held on Thursday, June 21, 2018, at 12:15 p.m., at the CN Headquarters Lobby, where the CN Employees' and Pensioners' Community Fund is situated, at 935 de La Gauchetière Street West, Montreal, Quebec, H3B 2M9.

2. ELIGIBILITY

- 2.1. This raffle is open to residents of Quebec who are 18 years or older, except members of the raffle organizing committee as well as employees (permanent or contractual) of the Children's Wish Foundation and of the CN Employees' and Pensioners' Community Fund.
- 2.2. The raffle sponsor reserves the right to check the age, identity and residence of any person claiming a prize.
- 2.3. For the purposes of applying these rules, the participant means the person whose name is indicated on the raffle ticket purchased before the closing date, as stipulated in paragraph 3.1.

3. HOW TO ENTER

- 3.1. To enter the raffle, a ticket needs to be purchased from a volunteer employee of Investors Group, CN, National Bank or another raffle representative. Tickets are \$10 each. The sponsor has made 20,000 tickets

available for sale. Tickets will be on sale from May 1 to June 8, 2018 inclusively.

4. DESCRIPTION OF PRIZES

Each raffle ticket gives you the chance to win one of following six (6) prizes. Prizes will be drawn in the following order:

- 4.1. The first ticket drawn will earn a gift card for Tocara jewellery – Marie-France Reid, worth \$750.
 - Only redeemable through Marie-France Reid, Tocara Independent Consultant.
 - Can be applied against any jewellery available from the 2018 collections.
 - Prize cannot be redeemed for cash value, and cannot be refunded.
- 4.2. The second ticket drawn will earn an Apple iPad Pro 256 GB, worth approximately \$1,400.
 - Prize cannot be redeemed for cash value, and cannot be exchanged.
 - Will include purchase invoice. For any breakdown, malfunction or other, please refer to the store where the purchase was made. Subject to the merchant's rules.
- 4.3. The third ticket drawn will earn a food competition for 20 people with Chef Jonathan Garnier at La Guilde Culinaire, worth approximately \$2,900.
 - Alcohol not included.
 - Depending on the availability of Chef Jonathan Garnier or another professional chef at La Guilde Culinaire.
 - Depending on the availability of the space at La Guilde Culinaire.
 - Activity cannot be fulfilled in November or December.
 - Prize cannot be redeemed for cash value.
 - Expires June 21, 2019 without any possibility for an extension.
- 4.4. The fourth ticket drawn will earn a Microsoft Surface Book 2 512 GB, worth approximately \$3,700.
 - Prize cannot be redeemed for cash value, and cannot be exchanged.
 - Will include purchase invoice. For any breakdown, malfunction or other, please refer to the store where the purchase was made. Subject to the merchant's rules.

4.5. The fifth ticket drawn will earn a Registered Education Savings Plan (RESP) or a Registered Retirement Savings Plan (RRSP), worth \$5,000.

- Prize cannot be redeemed for cash value, and cannot be exchanged.

4.6. The sixth ticket drawn will earn an all-inclusive one-week vacation package for two (2) adults and two (2) children to *Grand Sirenis Mayan Beach Hotel and Spa* (or equivalent), in Riviera Maya, Mexico, including round-trip flight on Air Transat in Economy Class, all worth an approximate commercial value of \$7,000.

- This package includes the fuel surcharge, service fees and taxes.
- This package must be fully redeemed before April 1, 2019.
- There are blackout periods: Christmas holidays, New Year's day, Easter and school breaks, among others.
- The form that will be provided to the winner after the draw must be duly completed and signed by the person who will be travelling and returned by email or fax to Transat no later than 30 days after the draw for identification purposes (the actual reservation can wait).
- Certain conditions apply.
- Prize is non-exchangeable, non-transferable, non-refundable, and has no cash value.
- Certain dates are not available. The winner must therefore choose from among the options offered by the tour operator.
- All the winner's personal expenses are not covered.
- Travel insurance is not included with the prize. It is strongly recommended that the winner of the travel certificate purchase travel insurance.
- It is the responsibility of the travel certificate winner to obtain all travel documents (passport, visa, etc.) and vaccinations that may be required or recommended for the package destination.
- The raffle sponsor and its partners reserve the right to offer a comparable product in case of cancellation, natural catastrophe or any other eventuality.

5. WINNER, PRIZES AND PRIZE ACCEPTANCE

5.1. Prizes cannot be redeemed for cash value and winners must accept their prize as awarded.

- 5.2. No exchange or prize substitution is allowed.
- 5.3. Prizes cannot be transferred unless the selected participant confirms transfer of his/her prize in writing.
- 5.4. To be declared a winner, the participant whose ticket is drawn ("Selected Participant") must satisfy the eligibility conditions of the raffle, as indicated in the terms and conditions. If the Selected Participant does not comply with the stipulated terms and conditions, he/she may be refused the prize and another participant may be selected to be awarded the prize.
- 5.5. The chances of winning are specific to each draw at the time of the drawing and depend on the number of tickets purchased by the participant and the number of tickets sold by the volunteer employees of Investors Group, CN, National Bank or other representative of this raffle prior to the draw. 20,000 tickets were printed by the raffle sponsor and numbered from 00001 to 20,000.
- 5.6. The raffle sponsor will contact the Selected Participants within ten (10) business days following the draw by calling the phone number indicated on the ticket stub. In the event that Selected Participants cannot be reached before that time limit, the sponsor will hold a new draw to determine a new Selected Participant.
- 5.7. To be declared a winner, the Selected Participant must sign an acknowledgment of compliance, as described in paragraph 6.1. Should the Selected Participant fail to comply with these rules, he/she may be refused the prize and another participant may be selected to be awarded the prize. Once the participant has been in contact with the sponsor and has signed the acknowledgment of compliance, arrangements will be made to remit the prize to him/her.

- 5.9. Should the winning participant fail to claim his/her prize within the time limit indicated in point 5.6, the sponsor will hold a new draw to determine a new Selected Participant.

6. ACKNOWLEDGMENT OF COMPLIANCE

- 6.1. Before being declared a winner, the Selected Participant will be required to sign an acknowledgement of compliance, indemnifying and holding harmless the raffle sponsor and its affiliated companies, its advertising or

promotion agencies, the providers of the prize, the members of these groups, and employees, agents, consultants, representatives and their respective successors and assigns from any liability or prejudice of whatsoever nature that they might incur or suffer arising from the acceptance or use of their prize.

- 6.2. The name, quotations, place of residence and photos or other representations of the winner may be used for advertising and other promotional purposes without other remuneration or compensation. By accepting the prize, the winner gives his/her consent thereto and to signing a release in a form satisfactory to the raffle sponsor upon request.

7. MISCELLANEOUS PROVISIONS

- 7.1. This raffle is sponsored by the CN Employees' and Pensioners' Community Fund. All decisions of the raffle sponsor are final.
- 7.2. The sponsor of this raffle disclaims any liability for any prejudice incurred or loss suffered directly or incidentally, in part or in whole, by entering the raffle or the acceptance or the use of the prize.
- 7.3. The raffle is governed by all applicable federal, provincial and municipal laws. The raffle is void where prohibited by law.
- 7.4. The raffle sponsor and its partners agree to not disclose your personal information or the personal information of anyone whose name you have provided to us. The information collected for the purposes of this raffle cannot be exchanged or used by the raffle sponsor or its partners.
- 7.5. Raffle entry tickets will be kept on file for a period of one year and then destroyed.
- 7.6. For Quebec residents only: Any dispute regarding the organization or running of a promotional raffle may be submitted to the Régie des alcools, des courses et des jeux ("Régie") for a ruling. Any dispute regarding the awarding of a prize may be submitted to the Régie only for the purpose of helping the parties reach a settlement.
